Fowler Hamilton Visiting Research Fellowships **September 2027 - July 2028**

Applications for Fowler Hamilton Visiting Fellowship are invited from researchers currently living outside the UK, in the Humanities or the Social Sciences, in the period September 2027 - July 2028. Applicants may apply for a period of three, six or ten months during this period.

Christ Church

Christ Church, one of the largest colleges of Oxford University, is strongly committed to teaching and research. The College has around 470 undergraduates and 250 graduates, and around 200 senior members. Our academics teach their students in tutorials, a system which enables undergraduates to work with experienced tutors in small groups. The subjects offered at Christ Church cover the whole spectrum, including Arts, Social Sciences, Medical Sciences and Physical Sciences. Fowler Hamilton Fellowships

The Fellowship Fund was established in the name of the late Fowler Hamilton, an American Rhodes Scholar of Christ Church. The Fellowships are intended to enable distinguished senior scholars and creative artists to pursue their own research as members of the college, providing an opportunity for academics to benefit from an association, and engage in the academic and social life of Christ Church.

Terms and Conditions

Fowler Hamilton Fellowships are offered on a non-stipendiary basis. Fowler Hamilton Fellows are not employees of Christ Church and the Fellowship does not constitute an employment.

Fellows are normally expected to give a talk on their research, or in some way to present their creative work, to members of Christ Church.

The tenure of each Fellowship is negotiable, but the following periods are suggested:

- from 1 September 2027 for 10 months
- from 1 September 2027 or 1 January 2028 for 6 months
- from 1 September 2027, 1 January 2028 or 1 April 2028 for 3 months.

Benefits

Holders of a Fowler Hamilton Fellowship will be provided with:

- A 3-bedroomed furnished family apartment (free of rent), situated about a mile from the college.
- Use of a study in college.
- Membership of the Christ Church Senior Common Room, enjoying full Common Room dining rights.
- Paid return economy fares from the country of residence for the Fellow and their family.



Eligibility and Selection Criteria

- Applicants should hold a PhD/DPhil in any discipline in the Humanities or Social Sciences or demonstrate equivalent experience in creative research.
- Applicants should be recognised as a leading authority or practitioner in their field, with an established international reputation and a substantial record of professional, research or creative achievements.
- Applicants should demonstrate the ability to lead or contribute to research or creative projects, strategies or groups.
- Applicants should demonstrate engagement with the wider academic or cultural communities at national or international level, through collaboration, public engagement, or contribution to professional associations and/or international bodies in support of relevant policy and research developments.
- Applicants should have a proven record of research or creative outputs commensurate with the applicant's discipline and career stage, and evidence of continuing research or creative activity.
- To be eligible, applicants must live outside the UK.
- Applicants should demonstrate evidence of securing or contributing to research funding, or an ability to identify and pursue relevant sources of funding).
- The proposed project should demonstrate intellectual rigour, development of innovative understanding in their field, a potential for significant impact in and beyond the applicant's field, and a clear fit with the University of Oxford's priorities in terms of research or creative endeavours.

In 2027/28, preference will be given to an academic researcher.

Applications will be judged only against the criteria which are set out in the Further Particulars, and applicants should ensure that their applications show clearly how their skills and experience meet these criteria.

Christ Church is committed to fairness, consistency and transparency in selection decisions. Members of selection committees will be aware of the principles of equality of opportunity, fair selection and the risks of bias. Applications are particularly welcome from women, and black and minority ethnic candidates, who are under-represented in academic appointments at Christ Church.

If, for any reason, you have taken a career break or have had an atypical career and wish to disclose this in your application, the selection committee will take this into account.

Application documents should include:

- Full CV and publications list.
- Covering letter or statement explaining how you meet the criteria set out including: examples of your skills and experience (this may include experience gained in education or employment), an outline of the proposed work to be undertaken and the future direction of your research, reasons for applying for this Fellowship at Christ Church, and proposed dates of the Fellowship.



- Names and contact details of two referees. Your referees will need to upload their letters of recommendation to the online application system by **Noon 2 March 2026**.

Appointments will be subject to current and valid permission to be in the United Kingdom and permission to undertake the activities in question.

It is expected that successful Fowler Hamilton appointments will be announced during **May 2026**.

References

Two references are required for this appointment. Candidates are responsible for requesting references from their referees. Referees should submit references online by the closing date of the competition. Once applicants have provided their details in their online application, referees will be sent an email containing a link to do this. Applicants should therefore give referees enough time to write in their support. The college will not request references directly from the referees.

Christ Church is grateful to referees for their assistance; and it hopes that they will understand the impracticability of acknowledging receipt of referees' letters.

Offer of Appointment

Applications for these Fellowships will be considered by a selection committee. The selection committee is responsible for conducting all aspects of the selection process; it does not, however, have the authority to make the final decision as to who should be appointed. The final decision will be made by the Governing Body of Christ Church based on a recommendation made by the selection committee. No offer of appointment will be valid, therefore, until and unless the recommendation has been approved by the Governing Body, and a formal appointment offer has been made.
