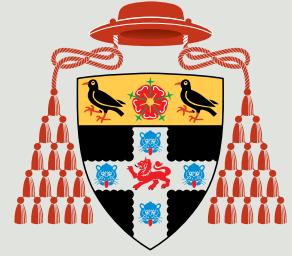
Gifts of \$35k or more make the donor eligible for membership of the Board of Benefactors. The same sum given to the historic buildings fund enables the donor to name their room.

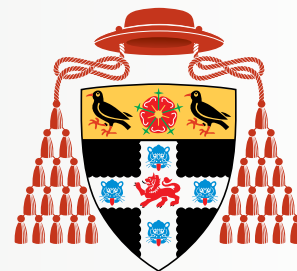
